Presidents Update

Clodagh McCowen gave the President's report. Clodagh offered thanks to Minter Ellison for again allowing us back to their office to hold our forums. She expressed we were grateful for the opportunity to be back face to face whilst still offering an online component for those who can't make it.

Clodagh delivered a summary of the ASIEQ Conference. She was pleased to announce that it was a very successful Conference on 9 and 10 March 2022 at the Brisbane Sofitel. The Conference report was included in the papers for the meeting. The event was designed to be a multidisciplinary event exploring the unique and ground breaking ways organisations have pivoted to not just survive, but progress in these strange times.

We had a total of 18 meetings over 12 months to pull the conference together. There were some concerns around health and safety in the lead up however extra measures were implemented to ensure everyone was kept safe.

In addition to the sponsors, we also had a number of organisations take trade booths. Sponsors and trade exhibitors were very happy with many saying they would like to be involved in future events.

41% of attendees responded to our conference survey. There was overwhelmingly positive feedback. Attendee highlights included our keynotes Gus Balbontin and Georgia Murch. There were different types of speakers who were thought provoking and well received. Topics such as medicinal cannabis, prevention, compliance and case management and secondary Psych were noted. Everyone enjoyed being able to see one another again.

We had our soiree which we had hoped to be outside however due to weather it was held in the Ballroom foyer. It was still an excellent night that was very well attended.

We had a197 attendees and the conference report gives a breakdown to the background. Clodagh offered thanks to members and associate members who attended. The event was designed for you to get benefit from your membership.

We had 35 speakers and we were very grateful to everyone who provided a high level presentations. The hardest part was fitting everyone in and we had different streams to accommodate a good variety of speakers.

We took additional safety measure as mentioned to ensure everyone's safety. This included posting Rapid Antigen Tests to everyone and it gave attendees confidence that we had taken strong measures to keep everyone safe.

The conference report was provided to OIR as part of our Sponsorship agreement. This is a good foundation for future events.

We were lucky to make a profit as the aim was not to run at a loss. There was \$161 400 in income, expenditure was \$116 000 and our surplus was \$45 311 which is a healthy injection into the Associations account. Clodagh offered any members with additional questions to contact either herself or Danielle to discuss.

There was a meeting held with WCRS on 28 April which Cara will go through in detail later in this meeting. There are concerns around the progression of issues such as the Rehabilitation and Return to Work Guidelines. It is important that as an Association, we keep the pressure on these issues. There were also some interesting conversations around fraud referrals. This topic will be discussed

further at the members drop in session as you can go back within 2 two weeks if you're advised that there are not good prospects to further your case. There were also concerns raised around the length of time for regulator reviews which were acknowledged and are being addressed. If members are having significant delays, please advise us so that we can raise the issue with WCRS.

There will be a Member Drop in session on 3 June which we have been hosting every 2 months to discuss topics that are impacting Self Insurers. Topics that have been raised for discussion include:

- Difficulties with Re-insurance
- Rehabilitation and Return to Work Plans
- Safety Audit samples 10% or square root
- Common trends
- Covid claim lodgements
- Claims management manual expectation

These sessions are a safe space for Members to discuss issues as they are not minuted or recorded. Please advise if you have any other topics.

The Licence Managers luncheon is on 15 June at Brisbane Town Hall. It's slightly later than usual due to the Conference being held in March. We hope all Licence Manager's will attend.

Treasurers Report

Victoria Barham gave the Treasurer's report.

- Bank Balance as of 30 April 2022 \$212 909
- Outgoings for April were \$16 164 resulting in a loss for the month of \$23 895 once the GST for the quarter was paid. This was a result of all income for the conference being received but the final payments for venue etc were still to be made.
- The Conference ran at a surplus of approximately \$45k

ASIEQ and WCRS Meeting

Cara discussed the minutes from the recent meeting with WCRS held on 28 April.

One of the key issues discussed was the Accredited Return to Work plans and guidelines and the timeline that this will be implemented. WCRS have advised they received more comments than expected on the draft which has delayed the release of these documents. The expected release is now mid year.

Sub Committee Reports

NCSI

Trent Rickard advised that NCSI are holding a special general meeting today to disband. Robin Shaw, the head of SISA (Self Insurers of South Australia) is retiring at the end of June and as he was the driving force of NCSI, it is not disbanding. They haven't been an active organisation for some time. If they wind up, some funds may come back to ASIEQ.

General Business

Bill Nevin raised the issue that Glencore will be returning to the scheme as they have not been able to secure re-insurance. Bill will be giving a detailed presentation on this after morning tea.

Rosemary Neal from GFG Alliance asked it any other members are having issues with quarterly meetings with WCRS. UQ advised they have had issues however Teys, Qantas and QR have had theirs quarterly. This issue was noted and ASIEQ will raise this issue at our next meeting with WCRS.

Cara asked members to submit suggestions for future Forum topics to the Secretariat.

The next General meeting and forum will be held on Wednesday 17 August 2022. The meeting will be held at the offices of MinterEllison, Level 22, 1 Eagle Street, Brisbane.
