Acknowledgement to Country

Cara asked everyone to take a minute to think about the traditional owners of the land on which they stand.

Review of the previous Minutes

The minutes from the 2021 Annual General Meeting had been approved at the General Forum Meeting on 17 November 2021.

Presidents Report

Clodagh thanked the members for joining us today. 2022 has been a very big year.

The self-insurance conference was a major event for the association and Clodagh was glad to say it was a tremendous success. Held over 2 days at the Sofitel in Brisbane, our conference had the theme of pivoting and progressing. Despite there being another surge of covid cases in early 2022, with additional safety measures in place we were able to host a successful, safe and informative conference. The conference was attended by 197 participants, included 36 number of speakers and presenters and made a financial profit of \$43 511.

We also had 2 legal Seminars thanks to Mark Weimers and the continued support of Barry Nilsson Lawyers.

We held 7 Drop in sessions for members to attend to discuss matters in a confidential environment.

The ASIEQ Committee held 3 regular meetings with WCRS and 2 meetings with WorkCover Queensland. In addition to this, there were additional meetings scheduled with WCRS to address specific topics such as new developments with claims farming and other legislative changes.

- There will be a query with WCRS on when the audit framework will undergo review as this was meant to happen 12 months after it was finalised in July 2021.
- We need to start planning for the 5 year legislative review and what amendments we think need attention.
- We will continue with drop in sessions to support members.
- We may consider some masterclasses to assist with training, learnings and professional development for case managers.
- And last but not least, we have our Christmas Party on 15 December 2022. The venue is still being confirmed, but there are a two tickets for each member so please make sure you make good use of these tickets and we look forward to raising a glass to the end of the year and celebrating everything we have achieved!

Clodagh was looking forward to being a part of the Association in her third and final year as President. At the end of 2023 she will need to step down from the President's role and move to a different position or take a break. Clodagh is looking forward to 2023 and contributing to the growth of the association, increasing our communication with those at WCRS and looking for professional development and networking opportunities for all members.

Auditor for 2023

Victoria noted that we had changed auditors throughout the year as Mike McFillin had retired. He recommended Sally Byrne BCom, CA to prepare this year's audit and she had done an excellent job.

Victoria proposed that we continue to use Sally Byrne for future audits.

Victoria Barham (Treasurer) moved a motion to nominate Sally A. Byrne to be the 2022/23 Auditor. Seconded Louisa Hackenberg. None Opposed. Motion Passed.

Alteration to the ASIEQ Constitution

Cara advised that some of the membership processes were not well reflected in the current ASIEQ Constitution. For this reason, a number of changes have been proposed. The most substantive change is that the current members meeting quorum was sitting at 50%+1 however with the challenges of the last few years we have struggled at times to meet such a high threshold. The suggested change is to drop the quorum to one third of total full members plus one.

Cara Williams (Secretary) moved a motion to accept all the proposed changes to the ASIEQ Constitution. Seconded Trent Rickard. None Opposed. Motion Passed.

Elections

Danielle Bolton acted as the Returning Officer and declared all positions vacant. She noted that one nomination for each of the following positions had been received by the due date.
